UBC Commission on Local Safety Competition 2012

The filling (sense) of security and safety is one of the most important needs of a human being, and particularly of our children, of any age. The most exposed to a wide range of hazards are young people in schools. Therefore, our Commission has decided to announce the grant competition for secondary or high schools being UBC members. The Commission will select and reward the best project which should comply with one or more of the following requirements:

- projects have to be based on and include youth suggestions/ ideas
- The project must address safety problems occurring in the school or its surroundings, with proposals how to deal with it

Aim of the competition

- To improve safety in schools and their surroundings
- To promote and to build up a sense of responsibility for a common property
- To promote responsible behaviour
- To improve safety and public order
- To develop commitment to the common good

Rules of participation

1. Eligibility (who can apply)

This competition is addressed to the UBC member cities. It is intended only for secondary and high schools, which are eligible to participate in the competition. With secondary and high school the commission means pupils at 12 – 18 years of age. Each UBC member school may submit only one application.

2. Grant

The Local Safety Commission will select and award the best project which fulfils above-mentioned requirements. The best project will receive a grant of EUR 2,000. The grant will be awarded to the project realised between November 2012 – December 2013.

3. UBC promotion

The school which will be awarded the “Safe & cool” grant is obligated to use the UBC logo in all publicity materials (press briefings, promotional materials, posters and web sites). The logo should always be accompanied by the following by-line: “co-financed by the UBC Commission on Local Safety”.

4. How to enter the competition

The UBC member secondary schools wishing to apply for the “Safe & cool” grant should fill in the enclosed application form and send it to the UBC Commission on Local Safety Secretary by e-mail (ubc@strazmiejska.gda.pl) or fax: **+48 58 346 28 11**.

5. Deadline:

The completed application forms should be submitted by **15 September 2012** at the latest.

Assessment of applications

1. Project assessment criteria

The project must:

- be submitted by an eligible applicant
- be submitted before the deadline
- comply with the requirements

When the project fulfils the conditions mentioned above, it will be evaluated with regard to its content.

2. Announcement of results.

The decision of the UBC Local Safety Commission will be announced latest by the end of October.

Reports

The school awarded the “Safe & cool” grant is obligated to submit a report within 30 days from the project completion date. It should be written on a special form which will be attached to the announcement of results.

The reports should contain:

- detailed description of project realisation
- photographic portfolio (preferably digital photos)
- press cuttings (if available)
- financial documentation (copies of invoices showing what the grant has been spent on)
