Definition of homelessness

There is no one definition of homelessness

- Situation when people do not have permanent home or means of livelihood
- Living without a conventional home and lacks most of the economic and social supports that a home normally affords
- Situation in which people's homes do not meet basic standards

Three broad areas of homelessness

- Primary homelessness: People without conventional accommodation, such as rough sleepers, squatters etc.
- Secondary homelessness: People who frequently move between temporary accommodation, emergency shelters sleeping on couches etc.
- Tertiary homelessness: People who have insecure tenure and who may be staying long term in boarding houses where they do not have private bathroom or kitchen facilities.

Homelessness statistics

- There is about 100 million homeless people in the world
- An approximate 1 billion did not have suitable housing Source: United Nations Commission on Human Rights, 2005
- An estimated 3 million people are homeless in Europe Source: Red de Apoyo a la Integración Sociolaboral (RAIS) 2010
- 30 to 200 thousand homeless people live in Poland Source: Ministry of Labour and Social Policy 2009




Homelessness in Gdansk

Number of homelessness people in Gdansk




Age and Sex structure
