ILLEGAL STREET TRADING

Definitions

- "Street Trading" means, the sale and exposing or offering for sale any article (including a living thing) in a street
- "Street" includes any road, footway, beach, or other area to which the public have access without payment
- "Illegal Street Trading" means seling, exposing, offering for sale the goods without the appropriate licence or in an undesignated area

Every attractive for the tourists city in Poland has a problem with illegal street trading



The specificity of illegal street trading

- increase during the summer time
- goods related to a specific event (festivals, holidays, Christmas time, sport events)
- subject of trade: local souvenirs, gadgets, toys, handicrafts, household items
- goods of dubious quality
- no possibility of returning purchased item and regain money
- makes unsightly image of city

Negative impact of street trading

- street traders flout environmental and pedestrian walkway regulations
- street trading makes unfair competition to legitimate traders and businesses
- substantial risk of nuisance to the public from noise or misbehaviour, particularly in residential areas

Places where illegal street trading exists

- places mostly visited by tourists
- historical part of the city (Main City)
- beaches
- city markets
- residential areas
- railway stations

Law

- In Poland street trading is regulated under the Petty Offences' Code (Article 99)
- Under that legislation, the Local Authorities has power to regulate street trading by requiring persons selling or offering to sell goods and services in a public place to hold a licence

Managing illegal street trading

- Local Authorities have a right to confiscate the goods from illegal street traders
- Articles recovery can be done only after receiving payment of fine



Actions taken by Municipal Guard of Gdansk

- interventions (3236 in 2010)
- assistance during confiscation of goods
- werbal warning
- patrols



According to the binding Law Municipal Guard in Poland has not powers to fine street traders

Most common offences commited by illegal street traders

- Lack of license for running business
- Trading on the public highway or other public places without Council Street Trading Permission
- Lack of visibility of price labels for articles
- Lack of scales legalization
- Devastation of green areas by traders

Municipal Guard of Gdansk cooperation against illegal street trade

- Public Roads and Green Areas City Agency
- City Hall Commerce Departement
- Gdansk Municipal Real Estate Mangement
- Division of Emergency Management & Civil Protection
- Office of Weights & Measures
- Office of Fiscal Control
- The State Trade Inspection







Following factors should be considered when tackling illegal street trading

- public safety
- public order
- needs of the area / character of the area
- local environment (street surfaces, power supply, supply chain, packaging, waste disposal and waste created by customers)
- food traders (they must hold a current Food Hygiene Certificate)
- importance of licensed businesses to the local economy (the legitimate businesses should not have to suffer diminished trade due to the competition from illegal street traders)
