Meeting started with a visit to Naestved Job Center, which is called the competence house. Naestved partners introduced their employment office working models and best practices dealing, for example, how they activate unemployed people through clean city maintenance.

Matti Mäkelä introduced general information about EU Strategy for the Baltic Sea Region.

Task Force activities: Spring 2015

Matti Mäkelä told that the results of the work of the Task Force were presented to the UBC Board in its' Kemi meeting in February.

Final version of the Solutions for the existing challenges is almost done. Task Force partners decided that the DL for new solutions/best practices is August 31st.

Project application for planning a joint project was sent to PSF in late March. The decision is expected in June.

In Riga meeting all partners agreed to arrange workshops about the best practices of TF partners. Results are as follows:

Naestved:

Conference in the end of March for professionals working with the youngsters (incl. politicians). Conference was also a kick-off seminar for the Task Force in Naestved. Task of this TF is to create a new strategy for youngsters in Naestved area. One starting point for the work is that we need to focus both on the youngsters with special needs as well as those with special skills.

There were 60 participants in the Conference.

Turku:

Youth Guarantee Now and in the Future -conference in April with 50 participants.

Workshop for project staff about the best practices of the TF partners. Two pilots have started after the workshop in order to transfer the best practices to Finland.

Karlskrona:

Planning to arrange a workshop during the next Fall.

Riga:

Planning to arrange a workshop in September.

Espoo:

Planning to arrange a workshop in the end of August.

Björn Bertilsson presented the activites of the new partner from the Linköping.

Back to basics: UBC Programme on Youth Employment and Well-Being – "The task of this Programme is to ensure that this issue gets the attention it deserves and to give support to Member Cities and other interested partners in promoting the rights of our young generation"

Members of the Task Force discussed about the results of the Task Force and how well or badly issues raised in the Programme on Youth Employment and Well-Being have been implemented in different cities and regions.

Participants agreed that one of the best things in TF work has been an opportunity to share ideas and best practices and learn from the others. Also, partners agreed that there has been visible changes in many themes mentioned in the UBC Programme. However, it is evident that there is many different measures and actors behind these changes. It seems very clear as well that for the future work and to take the next step from sharing and learning to really work and develop together TF partners will need extra funding in, for example, form of the project funding from EU or some other authority.
