CBSS Ministerial Session in Pori

The Ministers of Foreign Affairs of the Baltic Sea Countries met at the annual ministerial meeting in Pori, Finland, in June 2003. One of the important issues discussed was the 2nd Northern Dimension Action Plan (NDAP), where UBC has contributed actively. Another issue of direct interest for local authorities was Agenda 21 and Strengthening of Crossborder Co-operation.

The intensified co-operation on government level in the framework of CBSS, like Higher Education and Culture, Economic Cooperation, Maritime and Nuclear Safety, Civil Security and other fields, were met with satisfaction and further co-operation and development was welcomed.

New Report on Future EU Transportation Policy

The European Commission published June 27th a report from the "High Level Group on the Trans-European Transport Network". The group was set up in order to evaluate the present TEN (Trans European Network) policies and to propose necessary adjustments. The group consists of one person from each old and future EU country.

UBC has for several years argued that the TEN and the EU Transportation Policy is not suitable for the Baltic Sea Region as it concentrates on land and air transportation, but tends to forget ferry transportation although they are so important for our region.

The report proposes some adjustments of the present policy on land transportation. The new Finnish suggestion on "Motorways of the

Sea"-concept has also been included, however in a way that might create problems in the future, for example when defining routing of the "Motorways of the Sea". The report proposes, among others:

"To launch projects in practice, the Group suggests that current and future Member States submit to the Commission proposals before 2007 in relation to the objective of creating motorways of the sea (.....). These projects could take the form of public-private partnerships schemes whereby financial aid from the Community and national budgets would be jointly granted (...).

To be eligible for Community funding, these projects should:

- be proposed at least by two Member States;

- concern the smallest possible number of ports (ideally two in each different Member States);

- alleviate road traffic congestion on the main axes (or improve accessibility in the case of island States)"

It would be very difficult to define only one such Sea Motorway connection between two BSR states – if not handled properly, it could lead to fights between potential ports to get the proposed Sea Motorway to the own city.

It is probably time for lobbying already now from interested cities, and the first contact should be taken to the national member of the group, which is listed at the end of the report. UBC role is to lobby to upgrade Sea Transportation as a part of EU Transportation policy, but it becomes complicated if UBC would recommend one route before the other.

A New EU Instrument for Crossborder Co-operation

The European Union has adopted a communication on new instruments for crossborder co-operation in the new EU border regions with Russia, Belarus, Ukraine and other non-EU countries further south. The development of the new instrument will be carried out in two phases: One that combines the present funding sources (Interreg, Phare, Tacis) into a better functioning instrument, and one that foresees a new instrument that will start with the new EU budget from 2006.

UBC has for a long time argued that the EU Cross-border concepts and rules are not suitable for the Baltic Sea Region since they punish maritime borders. Only about 2% of the available EU funding for cross-border cooperation is allocated to the BSR, even though we do have more than 2% of the borders.

This new instrument will be excellent for the countries with land borders to Russia, Belarus and Ukraine. For cross-border co-operation between the Kaliningrad region and Sweden or Denmark the new instrument cannot be used. The conclusion is that UBC of course welcomes this new initiative, but should continue its efforts to adopt the cross-border concepts so they fit to the realities of the Baltic Sea Region. The first call for project under this new instrument is expected at the end of August 2003.

New guidelines for the INTERREG-programs

The EU Commission has published a guide for rewriting the rules and concepts of the Interreg programs in the Baltic Sea Region. The Monitoring Committee of the Interreg III BSR has nominated a working group that will deal with the practicalities. Each BSR Country has nominated one delegate to this Working Group. Bo Löwendahl from the Interreg III B Joint Secretariat is coordinating the group. The result shall be finished already in September, which gives UBC very limited time to intervene.

Poland ratifies EU Accession Treaty

Polish President Aleksander Kwasniewski ratified the Treaty of Accession on 23 July, completing the legal steps needed for his country to join the EU on 1 May 2004.

Upon ratifying the Accession Treaty, Mr Kwasniewski stated that "Poland is ready to do everything to make Europe stronger thanks to our presence in the EU". "I am sure that Poland's accession to the EU will be successful and will be satisfying for all of us," he added.

President Kwasniewski said that the most important tasks that Poland has to fulfill in the final months before joining the EU were setting up an effective system for Polish farmers to be able to obtain direct payments, adjusting Polish laws to EU standards and preparing local governments to be able to absorb EU development assistance.

Polish voters endorsed their country's EU membership in a 7-8 June referendum.

Latvia: Support for EU Integration Drops Below 50 %

Barely two months ahead of the 20 September referendum, has the Latvian public's support for the country's EU membership dropped below the 50 per cent mark, according to a survey conducted by an independent research company. The opposition gained 9.9 per cent to 34.5 per cent in July. 15.9 per cent had not made up their mind yet (against 18.4 per cent in June). In April, the independent pollster SKDS registered 53.8 per cent support for EU membership in the country.

Latvia is the last of the 10 new EU Member States to hold a referendum, which will be binding.

Estonian Politicians Argue on EU Accession

Mr. Edgar Savisaar, Mayor of Tallinn, influential politician and leader of the largest political party in Estonia, the Center Party, has supported a party recommendation to vote NO at the Estonian EU referendum September 14. The Center Party, with 25 % share, is the only party in the Estonian Riigikogu (Parliament) that does not support EU accession.

Recently leading Estonian political figures including President Arnold Rüütel, the parliament speaker, Ene Ergma, and the prime minister Juhan Parts – made a strong recommendation pro-EU joint statement.

The latest polls show accession support from 53 percent of voting-age citizens in the first half of July. In particular, support seems to be growing in the fifty-plus age group where support for accession is 61 percent, while among the young it remains below 50 percent.

Eastern Europe overtakes South and North in e-government

Eastern Europe in general has overtaken several Southern and Northern European countries in ICT use in the public sector and e-government, a new survey reveals.

The findings of the e-Forum Public Services Requirements Survey will be officially announced at the e-Forum Summit 2003 on 15-16 September in Valencia, Spain.

The goal of the survey, which was completed in two waves in the 15 EU Member States and in the enlargement countries, is to identify the key issues in successful implementation of egovernment applications as seen by senior public sector officials. According to the survey, some 90 per cent of Eastern Europe's public sector employees have access to the Internet, compared to 81 per cent in Northern Europe and 74 per cent in the South.

e-Forum is a project co-funded by the Commission under the Fifth Framework Programme. It seeks to promote the spread of e-government solutions throughout the EU of 25 over the next ten to 15 years.

Hanse – Tour Sonnenschein

This good will cycle ride organised by professor Ingo Richter, the retired director of the Children's and Youth Clinic at the Rostock University and the Rostock Authorities started at 25.07. Circa 100 participants rode a bike for two weeks for about 4.000 km around the Baltic Sea to deliver medicines, office equipment and other goods for the social institutions taking care of the ill children, like hospitals, hospices, care centres. children's houses in Poland. Lithuania, Latvia, Estonia and Russia. The money and the goods were collected in UBC cities: Rostock. Wismar, Lubeck, Kiel. Kolding, Copenhagen, Malmo, Kristianstad, Karlskrona, Kalmar, Oskarshamn, Vastervik, Nykoping, Stockholm, Turku and Helsinki and delivered to the institutions in Tallinn, Parnu, Riga, Liepaja, Palanga, Klaipeda, Baltijsk, Kaliningrad, Elblag. Gdansk. Gdynia, Koszalin, Szczecin and some other non-member cities. The first Hanse-Tour Sonnenschein was held in 1995.
