Ms Anna Lindh, Minister of Foreign Affairs, Sweden, died early Thursday morning September 11<sup>th</sup>. She died from wounds caused by a maniac who stabbed her with a knife in a department store in central Stockholm the day before.

Ms Lindh was a very popular politician, both in Sweden and among colleagues all over the word. She strongly supported the development in the Baltic Sea Region. She was also a great friend of UBC. Among others, the Swedish Ministry of Foreign Affairs supported UBC financially with substantial amounts during her term as Minister of Foreign Affairs.

The police are still searching for the murderer.

Mr Anders Engström. UBC Honorary President, has met Anna Lindh several times. He says:

"I had the privilege to meet Anna Lindh at several occasions, among others at the annual CBSS ministerial meetings where I could experience what a fantastic politician she was. Very few have the ability to combine intelligence, analytic sense and enthusiasm with a great social competence, popularity and joy as well as courage to push those political issues that were important for her even if it was against the party line.

During the ministerial meetings, after I had my speeches on behalf of UBC, she could send me a little note with the text: "Very good speech, Anders. What you said about ... sounds very interesting. Can we chat about it in a pause?" It was also she who introduced the informal tone at the CBSS ministerial meetings.

Last spring she called me herself (not any secretary which could have been expected) and asked me to send the greeting words in all Baltic Sea Region languages I used to use at different high-level meetings to break the ice. She also asked me if I miss UBC.

It was Anna Lindh who started to emphasize the importance of the decentralised co-operation in our region. Other Ministers of Foreign Affairs have after that followed the same track.

Sweden, the Nordic Countries and the European Union have lost a great politician and I hope that the struggle for democracy, freedom and solidarity will continue even stronger and in even greater unity"

# Most of the enlarged EU members oppose draft constitution

A large majority of the 25 Member States of expressed enlarged EU the have determination to renegotiate the European Constitution. At the informal meeting of the European foreign ministers in Riva del Garda last weekend, only the six founding members of the EU (France, Germany, Italy, Belgium, Luxembourg and Netherlands) defended the Constitution, proposed by the European Convention in July.

All other Member States of the enlarged Union expressed their firm intentions of negotiating the draft. They also rejected the proposal by the Italian Presidency of the Council and France to invite the Convention President Valéry Giscard d'Estaing to participate in the IGC.

All but the six founding members presented their lists of demands that should be discussed at the IGC. Some of the most contentious issues at the Riva del Garda meeting were:

- taking away the right for each Member State to have a commissioner;
- changing the voting weights (the new qualified majority would consist of a simple majority of states that represent 60 per cent of European population);

- abolishing the six-month rotating presidency;
- creating an EU foreign minister;
- create a European public prosecutor;
- excluding a reference to Christianity in the Constitution:
- including a mutual defence clause in the Constitution.

The Commission will put forward its amendments to the draft Constitution on 17 September, when it adopts its opinion on the results of the Convention. The European Parliament will adopt its report on the Convention at its 22-25 September plenary session.

The intergovernmental conference is scheduled to start on 4 October in Rome and is expected to be concluded before the end of the Italian Presidency on 31 December 2003.

The first EU Constitution could be signed on 9 May 2004 - Europe Day, just before the next European elections.

The treaty will be ratified by the 25 EU parliaments Between May 2004 and the end of 2005.

#### Easing Local Traffic over Europe's New Borders

European Union enlargement means that many citizens living just on the other side of its new borders will face new controls when they want to cross into what will become EU territory on 1 May 2004. Short family or business trips from Russia into Latvia, or Ukraine into Poland, for instance, could suddenly become complicated.

So to make life easier for people from non-EU countries who face this situation, the European Commission has made proposals on "local border traffic" - which is defined as "the crossing of borders by nationals of third countries who live in border areas and regularly travel for legitimate reasons to a member state of the Union without constituting a threat to security".

Possible solutions include special border-crossing points or corridors reserved for the inhabitants of border areas. And new types of document could be issued - such as a special visa for local border traffic, with limited territorial validity, but allowing the holder to cross the border repeatedly for stays of up to seven consecutive days, but for less than three months every half-year.

Each member state would be entitled to negotiate bilateral agreements with each of the non-EU neighbours concerned, because of the local nature of small-scale cross-border traffic, but the Commission's proposal lays down some common concepts. Border-control authorities issuing these special visas would need to conduct full security checks on applicants, who would have to have lived for at least a year in the country where they make their application, and would have to demonstrate why they need to cross the border on a regular basis. And any bilateral agreement would have to confer reciprocal rights on EU citizens wanting to cross in the opposite direction.

The proposals will be examined by the Council of Ministers, the European Parliament, the European Economic and Social Committee and the Committee of the Regions.

## Ireland plans enlargement ceremony in May 2004

Ireland will chair the European Union when the EU enlargement will take place. Irish Minister for European Affairs Dick Roche announced on 3 August that a special ceremony to commemorate EU enlargement will be held by the Irish Presidency of the Union in Dublin next May. Minister Roche said the purpose of the ceremony was "to display the diversity of the European culture and the unity of the European peoples".

Irish Prime Minister has invited heads of state and government from the other 24 countries of the enlarged Union to Dublin for the ceremony.

#### Launch of the Baltic 21 Report 2000-2002: Towards Sustainable Development in the Baltic Sea Region

Baltic 21 launched the hard copy version of the "Baltic 21 Report 2000-2002: Towards Sustainable Development in the Baltic Sea Region" - on 5 June 2003. The its web-based version was unveiled on 29 August 2003, on the day when the Environment Ministers of the Council of the Baltic Sea States had their meeting in Luleå, Sweden. The Ministers in their declaration determined to reinforce efforts to promote sustainable development for the Baltic Sea Region. The Environment

Ministers acknowledged that Baltic 21 report indicates major challenges to sustainable development in the Region. The Environment Ministers meeting as well as 12th Meeting of Ministers for Foreign Affairs of the CBSS held in Pori, Finland, on 10 -11 June 2003, welcomed the Report and noted the need to strategically develop the work. Baltic 21 will submit the Report and the outcome of its strategic work to the Prime Ministers' Summit that will take place in 2004.

The Baltic 21 Report 2000-2002 is a comprehensive guide regarding sustainable development of the BSR and addresses the three dimensions of sustainable development environmental, economic and social. The look the report takes a at Region's advancement towards the sustainable development goals by means of ca. 100 Baltic 21 indicators. It also contains a detailed description of the progress made by the Baltic 21 Sectors, Spatial Planning and selected Joint Actions in the implementation of the Action Programme.
