The Annual Working Session of the Commission on Culture will be held on 27-29 November in Bergen. The meeting of the Commission on Culture will be held at the

same time as the Mini Midi Maxi children's theatre festival; the festival is international in its scope – in 2007 performances from Sweden, Denmark, Germany, Russia, England and Norway were presented, with the addition of an international seminar and meeting program. The UBC forum will meet a number of the artists from the festival, as well as see at least one performance. The main theme of meeting is: "Art for Children practice and theory: Reaching children and young people is a core competence for cities". Social Campaign entitled "Always Active".

In order to counteract social exclusion originating from advanced age as well as to physical prevent consequent mobility restrictions, the UBC Commission on Sport has decided to launch the Social Campaign entitled "Always Active". The objective of the campaign is to promote an active lifestyle as a factor enhancing health and functional capacity as well as to stress the importance of healthy ageing process. It should be stressed here that the above mentioned targets are in line with the priorities of the World Health Organisation. Within the "Always Active" Social Campaign, the UBC Commission on

Sport intends to realise a number of activities, including the International Multidisciplinary Competition "Always Active" which will be addressed to elderly people (+55) living in UBC member cities. The objective of the competition is to encourage them to be creative despite their retirement years and advanced age. Additionally, the Commission would like to show the works of elderly people as well as their artistic and creative potential.

The competition will be held in the following categories:

- embroidery
- weaving miniature
- tourism (preparation of a small tourist guide that would present attractions of a particular UBC member city).

Participants should submit their works for the competition via a municipality or a local organization involved in the work for elderly people. The organizations whose representatives will win in each category (embroidery, weaving miniature and tourism) will be awarded 1000 EUR each. The Commission on Sport will also award prizes in kind (album books, fleece jackets etc.) for individuals who have won the first three places in each category. Open Days - Regions and cities in a challenging world

Under the theme of "Regions and cities in a challenging world", this event will serve as a platform on which participants can share their initial experiences of the Cohesion Policy programmes which began in 2007 and run until 2013. Total investment in these programmes, of which there are 345, amounts to some €500 billon of EU and national funding combined.

The event is geared towards EU and Regional makers, as well as Policy towards representatives from the world of business, banking and civil society. A record 216 regions and 32 countries have signed up as partners to the event and will host 235 local events throughout October as part of the "Europe in my region" project. French Prime Minister François Fillon will formally open the event on 6 October, alongside European Commission President José Manuel Barroso, Regional Policy Commissioner Danuta Hübner and Committee of the Regions President Luc Van den Brande. Over Open Days - Regions and cities in a challenging world Five thousand delegates are expected to participate in this year's annual "OPEN DAYS 2008 European Week of Regions and Cities" on 6-9 October in Brussels. They will hold over one hundred seminars on four main discussion areas - innovating regions, sustainable development, cooperation and networking, and looking forward to European Cohesion Policy for tomorrow.

New EU members work above European average

According to a recent report, a striking gap in working time continues to exist between countries that joined the EU after 2004 and the other 15 members. Among those working longer hours, Bulgaria, Romania and the UK are well ahead of their European neighbours. The average agreed weekly working time

currently stands at 38.6 hours for the whole of the EU, according to Eurofound's European Industrial Relations Observatory (EIRO).

But if one considers the EU 15 alone, rates have fallen to just 37.9 hours – two hours less than the 39.6 hour week put in by workers in the EU's 12 new members. As for full-time workers, Bulgarians and Romanians emerge as the hardest working, clocking up 41.7 hours per week. The UK comes a close third, with its citizens working an average of 41.4 hours. This could be a result of the country's opt-out from the EU's 'Working Time Directive' that caps the working week at 48 hours. Indeed, the opt-out enables British citizens to work for up to 65 hours per week, althouh the Socialist Group in Parliament has vowed to contest this, arguing that it breaks "health and safety law". Full-time workers in France, Italy and Denmark are those putting in the least hours. Indeed, the French spend just 37.7 hours at work, leaving them the equivalent of a whole afternoon off each week. France is in fact a record breaker as far as working time reductions are concerned. It has cut weekly working time by four hours over the past nine years, far ahead of Luxembourg (1 hour), the UK (1.1 hours), Portugal (1.2 hours) and Sweden (2.5 hours).

This tendency to work less would appear to contradict EU recommendations to speed up labour market reforms and get people to work longer so as to face up to the pressures of globalisation and deal with the demographic challenges facing the continent.

Nevertheless, even in France - seen as one of the EU's most rigid models and where trade unions have been actively opposing reforms change does appear to be taking place.

Indeed, in July, the French Senate approved a law to extend the compulsory cap of 35 working hours per week to boost the country's economic competitiveness.

EU population getting dangerously old

The EU's population is to gradually get older in the next 50 years, with those aged 65 or older likely to make up for almost a third of the bloc's population by 2060, a new survey has shown. The ageing trend will be most significant in Poland, where 36.2 percent of people will be 65 or more by that time, but also in Slovakia and Poland (36.1 and 35 percent, respectively). However, all EU states will be affected to an extent, with the average number of seniors jumping from 17 percent currently to 30 percent in 2060, according to a Eurostat survey published on 26 August.

"There would be only two people of working age for every person aged 65 or more in 2060, compared with four persons to one today," the survey says. The European Commission has expressed concern about the figures and their possible impact on the economy. "We are concerned with finding out whether our member states will be able to pay for the costs linked to ageing, and whether future generations will not be overburdened," said commission spokesperson Amelia Torres.

Beyond just ageing, the bloc's population will be decreasing as well. By 2015, the number of deaths will exceed the number of births in the EU, with immigration becoming the only factor boosting the bloc's population, the survey says. After an initial increase from 495 million currently to 521 million in 2035, the total population in the EU's 27 member states will again drop to 506 million in 2060. The population of Bulgaria is to shrink the most (28%), followed by Baltic countries Latvia (26%) and Lithuania (24%), as well as Romania (21%) and Poland (18%).

On the other hand, Cyprus is to note the most considerable rise (66%), followed by Ireland (53%), Luxembourg (52%), the UK (25%) and Sweden (18%). Germany – currently the EU most populous state, with over 80 million inhabitants, is to shrink to 71 million, and be overtaken by the UK and France, with 77 and 72 million people respectively. Italy (59 million) and Spain (52 million) are set to stay

in the top 5. Eurostat, the Luxembourg-based EU statistics office, has warned that the figures should be taken with caution however, as they are "what-if scenarios" that are "one of several possible population change scenarios based on assumption for fertility, mortality and migration."

Baltic economies continue freefall

The latest economic data from the Baltic stateshas revealed that the countries are continuing their fall into stagflation. Estoniahas so far been hit the hardest as it became the first country in Eastern Europe to dip into a recession following years of high growth driven by credit. The country registered negative GDP alongside a double digit inflation rate. "The decrease in the GDP was mostly influenced by the weak domestic demand and at the same time by the decrease in exports of goods and services," the national Estonian statistics service said in a report on the country's GDP growth. Estonia's inflation rate remained in the double digits in August at 11 percent. The statistics agency said a 17.1 percent increase in food prices was a main contributor to the still high inflation rate.

The numbers reflect the Baltic states' continued fall into a widely predicted economic hard landing. Latvia's inflation, meanwhile, fell for the third straight month in August but remained 15.7 percent, the highest in the Baltics. Inflationary data is not yet available for Bulgaria- which boasted the second highest rate in the EU in July at 14.5 percent - and so it is not yet clear whether Latviastill has the highest inflation rate in the bloc. "Price decrease of vegetables and fuel, as well as price increase of clothing, catering services and housing rent had the greatest impact on consumer price changes August," the Latvian national statistics office said in its report.

The country's GDP growth barely remained positive in the second quarter at only 0.1 percent higher than the same period in 2007. Many analysts predict that the trend will continue and the country will see negative GDP growth by the end of the year. Lithuaniahas so far suffered the softest economic landing of the three Baltic states. The country's average annual inflation rate in August hit 10.3 percent, while year-on-year GDP growth in the second quarter stayed at 5.3 percent.

Talking cars to save lives on EU roads

With traffic jams an almost daily feature of most commuters' lives, Brussels in August announced plans to increase Europe's radio spectrum for technology that allows cars to communicate upcoming road and traffic problems.

EU telecoms commissioner Viviane Reding said the decision was a "decisive step" towards reducing accidents on Europe's roads with statistics for 2006 showing that over 42,000 people died and more than 1.6 million were injured in road accidents in the European Union. She noted that 24 percent of driving time in Europe is spent in traffic jams - something that is expected to cost the economy €80 billion by 2010. "So clearly saving time through smart vehicles communications systems means saving said the commissioner in money," statement.

Similar decisions on smart communication between cars have also been taken in the US and Japan. The system envisages scenarios such a vehicles warning other cars about a slippery road ahead or traffic control centres sending messages about upcoming tailbacks and suggesting alternative routes. Now that the European Commission has made the extra bandwidth available, car manufacturers and telecoms industries can work on putting it in vechicles. The technology is expected to be

available in the next couple of years. The system will use 30Mhz of spectrum in the 5.9GHz band - something that will be allocated by national authorities to road safety outfits over the coming six months.

EU plans rules for self-extinguishing cigarettes

All cigarettes sold across the European Union will have to be "fire-safe" by 2011, meaning they will go out automatically if not puffed on minute. "By introducing extinguishing cigarettes, at least 2,000 lives could be saved in the EU each year," EU commissioner for consumer protection Meglena Kuneva told German newspaper Die Welt. After having received the green light from member states last November, the European Committee for Standardization of launched preparation the technical specifications for the safer cigarettes.

The new method should provide additional layers of thickened paper wrapped around a cigarette to slow the burning process.

"We think that by 2011 at the latest, these cigarettes will be on the market," an EU executive spokesman told reporters in Brussels on Tuesday (5 August).

Brussels argues that such products would prevent fires caused by cigarettes, with a survey from 16 EU countries suggesting that habits such as smoking in bed caused 11,000 fires annually between 2005 and 2007, killing 520 people and injuring 1,600.

Ttobacco companies are sceptical, however. Alison Cooper, a director of Imperial Tobacco Group Plc, has said that the term "fire-safe" is "misleading," adding there was doubt whether the new measures would bring any "real benefit," Bloomberg news agency reported.
