# Presentations: materials and products from each country

Materials show that in most UBC countries youth unemployment rates have raised during the last two years due to the well-known problems in European and global economy. # Workshops: Proposals and initiatives for the UBC Executive Board and UBC cities (based on the publication)

TF members discussed about the plans for the year 2015 and proposals for the UBC Executive Board.

#### **Results of the workshops**

The members of the Task Force decided that the work plan for the next year is as follows:

#### 1. Solutions for the existing challenges through TOP 7 questions

- 1) How to motivate youngsters? Tools and methods
- 2) How to promote social enterpreneurship and social economics?
- 3) How to recognize and validate skills of the youngsters?

4) New ways for guidance and support of Immigrant-youngsters that arrived in their teens

5) How we can use new technology more efficiently in guidance, support and education?

6) Steps from ill-being to well-being and employment

7) How we help the system to become more diversity-friendly?

Partners who didn't participate the Karlskrona meeting can suggest more questions before or during the next meeting in Riga.

Means to find the answers to the questions 1-5:

a) collecting the good practises (using, for example, existing UBC documents and other best practices from previous projects and development work)

b) transfer of innovation (study visits, lectures, workshops)

c) joint development to create new solutions

Means to find the answers to the question 6:

- use of a Dutch system as a starting point (presented by partner from Karlskrona), where the most important step is step number one (usually to get out of home)

- collection of similar processes in UBC and elsewhere in EU

- final outcome (dratf): UBC TF creates own model, which will be presented to the UBC Board

Means to find the answers to the question 7

- use of a Copenhagen aproach as a starting point (presented by partner from Riga)

- final outcome (draft): check-list for the diversity-friendly environment

Responsibilities and measures

- will be decided in Riga meeting

2. Joint projects

- Baltic Sea Region Conference in Warsaw 26.-27.11.

- planning of the joint projects together according to schedules given by EU and other possible funding authorities

- collection of project ideas (also other than mentioned in the TOP 7 questions)

#### 3. Final report and dissemination of the results

- short report from each city about the implementation of the UBC programme Promoting the Well-Being and Employment of Youngsters (2-3 pages)

- whole report will be presented in the UBC General Conference in Gdynia

- dissemination through web-sites (UBC-website, organisation's own web-sites and other web-sites), networks, seminars and dissemination events

- the best products will also be printed if there is a funding for that

Things that will be done between Karlskrona and Riga meetings

- finalising the interim report; DL for statistics and success stories will be 17th of October

- interim report will be presented for the UBC Board

- making a schedule for the joint project activities (EU schedules, DLs, themes etc.)

- collecting each cities' good practices / success stories to answer the TOP 7 questions to OpenDrive; DL January 16th 2015 (OpenDrive platform will be opened in early December)
